
C I R C U L A R

Dated Roing the 19th May, 2017.

It is to inform all the concern that from now onwards as per Hon'ble Supreme Court's Order conveyed the message by, the Govt. vide Order No.ARCS/08/09/2016/19 dated Itanagar the 30th Jan, 2017, following important points has been adopted by the District Administration, Roing to be implemented in related to the removal of hoardings and objects located within the distance of 100 mtrs from the State and National Highways;

- 1) All those hoardings which were installed earlier and are still remain should be removed on their own risk within 15 (fifteen) days from the date of issue of this Circular otherwise the same will be removed by District Administration and cost shall be recovered from concerned. Further, necessary action including imposition of fine, suspension/cancellation of Trading License for violation of lawful directions of District Administration shall be initiated.
- 2) Different group of NGOS/Pvt. Institutions/Local Tribes Festival Committee members in Roing are directed to seek permission from Dist Admn. before erection of such hoardings and should be removed immediately after completion of the scheduled programme/festivals on their own risk within 2-3 days time.
- 3) Installation of any kind of hoardings by private persons/individuals should be totally banned in premises of DC Office with immediate effect. Further, Departments shall obtain permission from undersigned for erection of any informative hoardings in the said premises.

Therefore, all concerned are directed to comply with this circular accordingly.


