EXECUTIVE ORDER

Whereas , it is reported that some anti-social activities like cultivation and trafficking of Poppy and Ganja are taking place at Bizari and Anpum village under Dambuk circle and whereas narcotic drugs are being trafficked for sale at local market and distribution in our district and nearby areas of East Siang district.

And whereas, it is illegal for a person to produce/manufacture /cultivate/posses/sell/purchase/transport/store and/or consume an drug or psychotropic substance as per Narcotic, Drugs and Psychotropic Substance Act, 1985.

And whereas, such cultivation and trafficking of Ganja, Poppy and other narcotic drugs in the bordering area of Arunachal and Assam is a serious threat to law and order problem/nuisance in the surrounding and disrupt public tranquility.


And whereas, with border Myanmar and China in the vicinity, the scenario can lead to external security problems as well.

And whereas, the menace is also leading to societal problems such as widespread drug abuse and increasing domestic violence.

And whereas, it is imminent to adopt zero- tolerance approach to opium cultivation, to check and stop drug trafficking.

Now therefore, to maintain the general law and order in the district, I, Shri Ravi Dhawan, IAS, District Magistrate, Roing direct Addl. Deputy Commissioner, Dambuk and Circle Officer, Paglam to report any such cases mentioned in para 2 to Police and get FIR registered.

This order shall come into force with immediate effect.


