EXECUTIVE ORDER.


WHEREAS, it has been brought to the notice of the undersigned that there is apprehension of road accidents and unruly behaviour in the District which in turn may lead to various law and order problems due to large scale consumption of alcohol during the Reh festival celebrations

WHEREAS, it has been deemed necessary to declare "DRY DAYS" from 1st Feb to 3rd Feb/2018 to prevent any untoward incident in the district.

NOW, therefore, I, Smti Mitali Namchoom, IAS, District Magistrate, Lower Dibang Valley District, and Roing hereby declare "DRY DAYS" from 1st Feb to 3rd Feb/2018 and prohibit selling of alcohol/IMFL by the wholesale/retail vendors from 1st Feb to 3rd Feb/2018 in the interest of public peace and tranquility in the district.

The consumption of local brew (Yu-Chi) shall be permitted only for cultural purposes and only within the festival ground.


Violation of this order shall be viewed seriously and action will be initiated as per law.
