//EXECUTIVE ORDER//

WHEREAS, 1230 Nos of Solar Home Lighting System was given to by the Director(APEDA) vide No APEDA/W-430/EESI/REC/2013-14/2162-86 dt 27th June 2015 for distribution to the beneficiaries of Lower Dibang Valley Dist.

AND WHEREAS, the Deputy Director (APEDA) Tezu division had clearly informed PO (APEDA) Roing to distribute the Solar Home Lighting System as per the beneficiaries selected earlier by mentioning clearly that the materials and the list of beneficiaries were already under the disposal of PO (APEDA) Roing. Vide No.APEDA/TEZU-DIV/SHS-100/2012/490-503 dt 21ST Jan 2016 and APEDA/TEZU-DIV/SHS-100/2011/521-23 dt 3rd Feb 2016.

AND WHEREAS, an order to PO (APEDA) Roing was issued for distributing the Solar Home Lighting System as per the beneficiaries selected and villages as appeared and the distribution proceeding to be countersigned by the concerned Circle officers, PRIs leaders and GBs Vide Letter No LDR/DEV-112/2015-16/35604-12 dt 12th Feb 2016. and also another letter was issued vide No LDR/DEV-112/2015-16/37009-16 dt 29th Feb 2016 to reiterate the criteria for the distribution of Solar Home Lighting System.

AND WHEREAS, The PO (APEDA) Roing issued a letter on 12/2/1016 to all ZPMs/ASMs Chair of Lower Dibang Valley Dist to re-select the beneficiaries for Solar Home Lighting System, which is ultravires, hence completely wrong, as the beneficiaries had already been selected and approved by Board headed by concerned Circle Officer constituted vide order No. LDR/DEV/112/2015/15780-88 dt 22nd Jan 2015.

AND WHEREAS, the office of the undersigned has received various complaints regarding improper distribution of Solar Home Lighting System from Bango, Bizarl (C) and Korunu circle.


Now therefore, all respective Circle Officers are directed to collect the approved beneficiary list from the office of the undersigned and submit the same to this office after obtaining signature of these beneficiaries confirming the receipt of the Solar Home Lighting System latest by 15th April, 2016.

All persons who have received the Solar Home Lighting System but are not as per the approved beneficiary list are hereby directed to return the same and register themselves with the concerned Admn Officer who shall submit this list also to the office of the undersigned.

Any failure to return or any other disobedience or obstruction to discharge this duty by any person shall amount to offence punishable U/S 183/186/188 IPC and other relevant provision of law. Concerned Circle Officer/Admn Officer is hereby directed to lodge F.I.R under the relevant provision of law at the nearest police station with intimation to the undersigned. A report be furnished not later than 15th April 2016.


