

**EJECTMENT NOTICE**

**[Notice under Section 3 (3) (i) of the Arunachal Pradesh Forest (Ejectment of Unauthorized Persons from Reserve Forests) Rules 2013]**

Whereas, notice has been issued to you vide this office No. DF/CONS-33/2016/3494-3501 Dtd. 05/10/2017 to show cause why should you not be evicted from the Reserve forests as per the Arunachal Pradesh Forest ( Ejectment of unauthorized persons from Reserve Forest ) Rules, 2013. Further, you were directed to appear before the undersigned on 16<sup>th</sup> October/2017 at 2 PM for personal hearing too.

Whereas in the reply of the above show cause notice vide your letter dated 16<sup>th</sup> October/2017, and also in the personal hearing, you had mentioned the following pointes to substantiate your claim of occupying the reserve forest land:-

- (a) That you are occupying the land in question since 1977, but no any evidence produced by you.
- (b) That the Deputy Commissioner, Lower Dibang Valley, Roing has acknowledged your right and title over the land but no any evidence produced by you.
- (c) That the Govt. of Arunachal Pradesh is regularizing the pre – 1980 encroachment of Deopani reserve forest but your said plot falls outside the de-reserved portion of the Deopani reserve forest.
- (d) That you had claimed relief under the Schedule Tribe and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 but no any papers of relief produced by you showing the orders of competent authority in this regard.
- (e) That you had mentioned only about the cultivation of ginger at the said plot in your application although a building has also been constructed in the same plot, which you had not mentioned.

In view of the above, the undersigned is satisfied that the land in question inside the reserve forests is under unauthorized occupation.

And therefore, now, I Shri Aduk Paron, Divisional Forest Officer, Dibang Forest Division, Roing, as per the power vested on me under Rule 3 (3) (i) of Arunachal Pradesh Forest (Ejectment of unauthorized persons from Reserve Forests) Rules 2013 hereby directs you to vacate the Reserve Forests on or before 8<sup>th</sup> November/2017.

Failure to comply with this notice, you will be ejected from the area and all the buildings / items / materials / crops etc will be taken under the possession of the undersigned which will be sold or confiscated or destroyed as deem fit.
