In pursuance of Govt.order No.ED./AR/RMSA/133/2015 Dated 02.02.2017, Applications are invited in the prescribed format from the citizens of India as defined under Articles 5 to 8 of constitution of India for filling up the various contract posts as indicated below under the terms of the relevant rules of 'Contract Service' at a consolidated pay under Rashtriya Madhyamik Shiksha Abhiyan (RMSA), District Mission Officer, Govt. of Arunachal Pradesh, Roing against the Govt.Secondary Schools of the Lower Dibang Valley Districts as specified below:

II. <u>Consolidated Pay</u>: Trained Graduate Teacher (TGT)

III. Reservation:

- (a) All post advertised are reserved as per Arunachal Pradesh Govt.norms i.e., 80% is reserved for APST & 20% is unreserved and open to all. However, there shall be reservation of 50:50 for the post of Junior Teacher (Science & Maths) i.e., 50 % is reserved for APST and 50% is open to all.
- (b) Reservation for the meritorious sports persons and Person with disabilities (PWD) will be as per the norms of Govt. of India and Govt. of A.P. The PWD candidates having 'Disable Certificate' issued by the Deputy Commissioner of the District and the meritorious sports person having Gold/Silver/Bronze in the International/National/Interuniversity Tournament/School Games in National Sports/Games National award in Physical efficiency etc., may apply along with sports certificates issued from the concerned competent Authority.

In Case of non-availability of such category of candidates the post will be treated as unreserved and filled up from the other category on merit basis.

IV. <u>Age Limit</u>: Maximum Age Limit as on 9th June 2017 is 21 to 33 years. However Upper age limit shall be relaxed up to 5(five) years in case of APST candidates.

V. Minimum Qualification:

- i) English/Hindi/Social Study: B.A/B.Com with B.Ed from any Recognized university.
- ii) Mathematics: B.Sc with Physics, Chemistry and Mathematics with B.Ed from any recognized university.
- iii) Science: B.Sc with Physics, Chemistry and Biology with B.Ed (PCB) and B.Sc with Physics, Chemistry and Maths (PCM) with B.Ed from any recognized university.
- VI. <u>How to apply</u>: Willing candidates having requisite qualification may collect the application in the prescribed format from RMSA Office, Roing available at Rs.350/during office working hours only and should submit to the office of the DDSE, Lower Dibang Valley District, Roing along with attested 5 (Five) copies recent Passport size Photographs, Attested copies of Certificate and Marksheet from Class-X to Graduation and B.Ed Degree, attested S/T certificate in case of APST, self addressed envelope with postage stamp of `.5/- only, The last date of the submission of the application is 9th June 2017 at 1630 hrs.

Application received after due date or time or incomplete in any respect will be summarily rejected.

VII Date of Written Test: 27th June 2017 VIII Date of Viva-Voce: 12th July 2017.

IX. <u>Mode of Selection</u>: Eligible candidates will have to appear the written examination as under:

i) Concerned subject (3hrs)	- 100 marks	There shall be separate
(ii) General English (2 hrs)	- 50 marks	papers in Eng,Hindi,PCM
(iii) General Knowledge (1½ hrs)	-50 marks	PCB, S/Study (Pol.Sc/Eco.
(iv) Vivo-Voce	-50 marks	Geo /History)

The candidates must secure minimum of 33% marks and above in each subject but should secure 45% in aggregate to qualify for the written examination to be eligible for appearing for Viva-Voce Test. The normal ratio for short listing the candidates for Viva-Voce test is 1:3. The selection will be made strictly on merit of the marks secured in the written/Viva-Voce Test.

X. <u>Appointment</u>: The Dy.Director of School Education, Roing is the competent authority for appointment.

'The Deed of Agreement' and appointment orders etc., will be done at the Dy.Director of School Education, Roing level.

- XI. No TA/DA will be admissible for appearing interview.
- XII. The appointments shall be purely on Contract basis under RMSA, the centrally sponsored scheme.
- XIII. Under the terms and conditions of the contract services, the contract appointees will have no right to claim for regulation of their services after expiry of the contract period.
- XIV. Extension of contractual service to the subsequent period will be subject to satisfactory performance.
- XV. Appointment shall be on the basis of 'No work No Pay'.
- XVI. The appointment shall be school specific and non-transferable.
