NOTIFICATION

Any person who has any objection to the land to be acquired as described below may file such objection in writing to the office of the Deputy Commissioner, Lower Dibang Valley within 30(thirty) days from the publication of this notification by clearly stating the reason for such objection and the concerned Deputy Commissioner, in his capacity shall dispose off the same after giving reasonable opportunity of hearing to extinguish the claim of the land owners.
