NOTICE UNDER SEC 9 OF LAND ACQUISITION ACT 1894

Whereas the Govt. of Arunachal Pradesh had issued Gazette Notification under Sec 4 (Preliminary Notification) of Land Acquisition Act 1894 vide its order No. LM-15/2009 Dated Itanagar the 27th August 2013 for acquisition of land for DMP (NHPC Ltd) in Lower Dibang Valley and Public Notice was issued by DC Roing-vide Memo No. DR/LR-182/13/30218-30418 Dated Roing the 17th Dec 2013

Whereas the Govt. of Arunachal Pradesh had issued Gazette Notification under Sec VI (Final Notification) of Land Acquisition Act 1894 vide LM-15/2009 Dated Itanagar the 14th Dec 2014 and public notice was issued by DC Roing Memo No. DR/LR-182/13/19466-666 Dated Roing the 24th March 2015

Whereas under Sec 7 of the Land Acquisition Act 1894, the Collector is to take order for acquisition of the said land and whereas under Sec 8 the map is to be marked out, the map prepared under Sec 4 and revised for Sec 8 (in pursuance of direction from the Ministry of Environment and Forest, Govt. of India) along with schedule of land is available for inspection in the office of DLR& SO, Lower Dibang Valley District. Now therefore this public notice under Sec 9 is given to all persons interested to state their claim and interest within 21 (Twenty One) days from the date of issue of this notice.


