ORDER

Whereas the DFO (T), Lower Dibang Valley, vide letter No. DF/CONS-33/10/4419-20 Dtd Roing the 6th Dec 2016 has clarified that the said stretch and adjoining areas fall under Deopani Reserve Forest,

Therefore, all claims received in the office for payment of compensation are hereby declared null and void. Further it is also declared that all claims regarding agricultural/horticultural/pasture land shall be dealt by the DFO (T) under relevant acts/rules governing reserved forest.
