//ORDER//

WHEREAS, Public representative and common people of the Dambuk area had lodged a complaint on poor and non-functioning of the Anganwadi Centres of ICDS Project of Dambuk area and non-station of the CDPO, the departmental authority for a long period in written and verbal as well.

AND WHEREAS, an enquiry has been ordered to the Addl. Deputy Commissioner, Dambuk about the complaints on the department and departmental authority.

AND WHEREAS, an inspection reports of the ADC, Dambuk reveals that the CDPO Dambuk, the departmental authority of the ICDS Project of the area has been remaining absent from the duty almost all the time without proper permission from the competent authority nor intimate the appropriate authority which is unbecoming of a responsible Govt. officer being a Head of important departments for the developmental activities in the village and grass root level and is violation of the Govt. order No.PERS/AIS-03/99(PT)2808, Dtd 18/04/2016.

AND WHEREAS, non-station of the departmental authority for a long period is the main effect and cause of the poor functioning of the Anganwadi Centres in the area.

AND WHEREAS, during the visit of the Addl. Deputy Commissioner, Roing on March'2016, the officer was found out of station without proper permission from the authority as reported by the ADC, Dambuk and public as well. Further, as per his findings and interaction with Anganwadi workers of 2(Two) centres, CDPO, Dambuk has not even visited their centres even once.

AND WHEREAS, this office had served a Show Cause Notice vide No.LDR/ESTT/SCN/15-16/8761-64, Dtd 20/07/2016 on the reasons aforementioned.

AND WHEREAS, the officer had submitted a written reply vide No. DBK/ICDS/PF/16-17/137, Dtd 3rd Aug'2016 stating her absence to be a one time event on medical ground without any documents proof and is unacceptable and non-considerable one.

NOW THEREFORE, in accordance with Chief Secretary's order No.CS/ESST(D)01/2015/32, Dtd 06/07/2015, the undersigned places Smt Yalom Saroh, CDPO, Dambuk ICDS Project under suspension with immediate effect on her gross negligence, dereliction of bonafide duty and violation of CS's order.


